Greystone's Campus Trails Legacy Fund Continues to Build Community Impact

Katherine Craine, Executive Director of the Huntsville Hospital Foundation, shared, "Seeing the Campus Trails project achieve the vision that Pat and Greystone created is so remarkable, and to see the fund grow every year is heartwarming. Their vision of a community that is connected, healthy, and vibrant — one that promotes healthcare and wellness — is truly inspirational. What a beautiful act to honour the new buyers of these condos with a generous donation to the hospital."

Greystone has pledged **\$1,000** per unit sold at Campus Trails. This meaningful gesture turns every home purchase into an act of care for the wider community.
